 - c) **DATA:** \$1500.00 AND UP (1st year).

5. Payment will start at the signing of the contract between HostDetour.com and the customer. Payment schedule is as follows:

- a) **INFORMATIONAL:** Payment in full at signing of contract.
- b) **INTERACTIVE:** Half payment due at the signing of this contract with balance due at the conclusion of the forth week (unless delayed by HostDetour.com).
- c) **DATA:** Half payment due at the signing of this contract with balance due at the conclusion of the forth week (unless delayed by HostDetour.com).

Note 1: Final payment by the client will be postponed or returned if HostDetour.com fails to complete its obligation by the forth week.

Note 2: Final payment by the client will be collected by HostDetour.com if Customer fails to complete its obligation by the forth week.

6. **Time Frame:** All projects will begin upon the receipt of the signed contract and corresponding payment. Each project will conclude the forth (4) week from the start date. These weeks are broken into four parts.

a) **Week 1:**

- A. Contract signed,
- B. Payment received,
- C. Data and Media Information gathered, and
- D. URL registered.

b) **Week 2:**

- A. Website's back ground structure constructed
- B. Data and Media information inputted.

c) **Week 3:**

- A. Website concluded and ready for review.
- B. Website reviewed for final revisions.

d) **Week 4:**

- A. Final revision concluded
- B. Control Panel reviewed for Customer's use.
- C. Final payment reviewed (if applicable).

Note 1: If a delayed occurs due to the Customer's neglect, the Customer's website design slot will be forfeited till the project can resume without any interruptions. The website's design schedule will commerce from the time of the delay.

7. All Materials may not be returned to the Customer unless specifically requested by the Customer. Materials will be discarded after twelve (12) months.

8. Customer shall submit to HostDetour.com all data and media materials no later than three (3) days prior to design start. Alterations requiring additional work after design completion will be charged at current rates. Cancellations must be received before the design close date. Customers canceling after this date will be billed for work done. No cancellations are accepted after closing dates without written agreement from HostDetour.com.

9. HostDetour.com reserves the right to reject any data and media materials at any time after receipt of proof of text, copy and/or illustrations, even though a prior similar order may have been approved. HostDetour.com shall have the right to omit any data and media materials when the space allotted to development has been filled. Unintentional or inadvertent failure to publish the website invalidates the insertion order for that issue only. - 11.** Any specification or order for the use or non-use of any particular page or position where the data and media materials is to be inserted shall be treated as a request only, and HostDetour.com shall not be obligated to comply with said request. In the event said request for position is granted, Customer shall pay an additional position charge.
- 12.** Any taxes which may be imposed on any advertising shall be advanced by HostDetour.com on behalf of Advertiser, be billed to Customers and be due and payable immediately.

- 19.** This Agreement shall be construed under the laws of the Republic of Liberia. Venue for any legal actions regarding this Agreement shall be in the Republic of Liberia.
